FINANCIAL MATTERS - Secretary, W. Areias presented the current financial report for the Board's consideration. A motion was made by Dir. B. Newton, seconded by Dir. T. Azevedo and carried to approve payment of the bills as listed and make any transfers needed.

BUDGET UPDATE - Copies of a Budget Update report for the period ending August 31, 2023 were distributed and reviewed by the Board.

VERSION 2 OF THE 2023-2024 BUDGET – Manager Silva presented the Version 2 of the 2023–2024 budget. A motion was made by Dir. T. Azevedo, seconded by Dir. B. Newton and carried to approve the Version 2 budget for the 2023-2024.

MANAGER'S REPORT - Manager Silva reported that Pine Flat storage is 718,535 a/f total storage is 904,006 a/f. The natural flow is 1,078 c.f.s. SID storage is a total of approximately 12,900 a/f, maximum storage 14,430 a/f. Coordinated water run will end on September 30, 2023. The 2022-2023 water year runoff into Pine Flat dam will be the highest on record. A Flood Release is projected for January 2024.

LEMOORE CANAL MEETING – Dir. B. Newton reported that Lemoore Canal made a 0.50 a/f allocation and to sell Excess water at \$30.00 a/f for the October run. The Lemoore Weir needs major repairs.

KRWA – ASO FLIGHTS - There has been six ASO Flights this year. Four flights are scheduled for next year via Cal Funds.

SNOW SENSOR – The State Lakes snow sensor is going to be repaired or replaced.

RAISE OF PINE FLAT – KRWA & KRCD each will be paying approximately \$90,000 in two years for the study to raise Pine Flat Dam.

SOUTH FORK KINGS GROUNDWATER SUSTAINABILITY AGENCY - Dir. T. Azevedo reported on the South Fork Kings Groundwater Sustainability Agency is that a new Prop 218 for \$10.10 an acre will be going out. There is a meeting tonight.

OLD BUSINESS: No old business to report.

- a) OCTOBER RUN/ALLOCATION A motion was made by Dir. B. Newton, seconded by Dir. T. Azevedo and carried to not make an allocation for the October run. Land owners can use what they need.
- b) LEVY ASSESSMENT FOR 2023-2024 A motion was may by Dir. B. Newton, seconded by Dir. S. Stanton and carried to levy an assessment of \$30.00 per acre for 2023-2024.
