MANAGER'S REPORT - Manager Silva reported that Pine Flat storage is 564,774 a/f total storage is 701,190 a/f. The natural flow is 387 c.f.s. Stratford's storage is approximately 12,900 a/f, 89.4% of max storage. Stratford ID's entitlement for the 2022-23 water year was 36,041 a/f, which is the second highest on record. Stratford flood released 23,747 a/f. Stratford delivered 17,477 a/f of water from February to October 2023.
