MANAGERS REPORT - Manager Silva reported that Pine Flat storage is 721,335 a/f, total storage is 823,869 a/f. The natural flow is 5,319 c.f.s. Stratford's storage is approximately 8,000 a/f. Snow Pillows are 67% to date.

LEMOORE CANAL MEETING – Manager Silva reported that Lemoore Canal made an allocation of 1.40 a/f of "A" water and 0.35 a/f of "B" water. Lemoore is starting at the Dam on April 20<sup>th</sup> and will probably reach us on Wednesday and run till September.

## KRWA:

NEW HIRE – Mr. Silva reported that KRWA hired a new hydrographer names Tanner Ozuna. He replaced Saint Joe.

AB639 - WEIR FEE - Manager Silva reported AB639 Weir Bill is advancing to the Assembly Floor.

KRWA WATER PROGRAM – Mr. Silva reported that it will cost \$40,000 to split Empire West Side and Stratford ID water account in the KRWA water program. Stratford share of the cost will be \$20,000. After discussion, the Board decided not to participate in the cost of splitting the account.

SOUTH FORK KINGS GROUNDWATER SUSTAINABILITY AGENCY – Director M. Newton reported that the next SGMA meeting is May 1<sup>st</sup> at 9 a.m. Ken Richardson has a draft of what they are proposing.

NEW BUSINESS – ALLOCATION – Manager Silva is recommending that Stratford ID do an allocation of their River water of 0.25 a/f per acre. A motion was made by Dir. T. Azevedo, seconded by Dir. S. Stanton and carried to allocate 0.25 a/f per acre to the Stratford land owners.
